The training period for PCIT is 18 months. On occasion, training has been extended for an additional 3 months. All training should be completed in 21 months unless trainee has been on medical leave. Any extension beyond this is at trainer discretion. If the trainee does not complete the training, the trainee may lose infant mental health certification if not trained in other EBTs.

Medical leave: If trainee goes on medical leave, the timing of continuation requirements will be decided on a case by case basis (2 active cases, video review requirements, etc.). All training for trainees with medical leave will be completed in 24 months.

Trainee moves to a different agency: If a trainee can begin to see cases (completed intake and identified as PCIT appropriate) within the first 2 months after starting at the new agency, they can continue. New agency leadership must agree to all PCIT requirements, sign all PCIT agreement documents, and purchase AV equipment within 1 month of trainee starting at agency. If trainee or agency is unable to meet these requirements, the trainee may reapply for a later cohort.
